

# 2022 “Sweet Indulgence” PROMOTION

## Terms and Conditions



### 1. STANDARD TERMS

- a. The Promoter is Arana Leagues Club Ltd (ALC).
- b. Information on how to enter forms part of the terms of entry.
- c. By entering the Sweet Indulgence promotion, you are agreeing to the following terms and conditions.

### 2. PARTICIPANTS

- a. Entry is open to financial members of ALC only.
- b. Management and Staff of ALC are ineligible to enter.

### 3. HOW TO ENTER

- a. The promotion commences on Monday 28<sup>th</sup> February 2022 at 10.00am (AEST) and concludes on Saturday 9<sup>th</sup> April 2022 at 6pm (AEST).
- b. ALC Members will gain one (1) entry ticket automatically into the barrel each time they meet one or more of the following criteria:
  - i. Every \$20 play on any gaming machine with their membership card inserted correctly
  - ii. A minimum purchase of \$10 in Bar & Grill, Café, Bar, Bottleshop and Bingo upon presentation of their membership card
  - iii. Swipe at the Member Kiosk in the club foyer each day they visit ALC throughout the duration of the promotion
- c. To activate promotion entries, members must swipe their Membership card at the kiosk on the day of each of the promotion draws, this can be done anytime from 10am. This will activate the entries they have accumulated from 28<sup>th</sup> February 2022.

### 4. THE PRIZES

- a. The total prize value of this promotion is \$21,750.
- b. The cash prizes available will be 18 x \$500 cash prizes and 12 x \$1,000 cash prizes, as well as 30 x giant confectionery jars
- c. The prize allocation is scheduled and will run as follows on each of the six (6) draw dates of the promotion as outlined in Section (5).
  - i. 2pm Draw: cash prize of \$1,000, plus winner's choice of confectionery jar
  - ii. 3pm Draw: cash prize of \$500, plus winner's choice of confectionery jar
  - iii. 4pm Draw: cash prize of \$500, plus winner's choice of confectionery jar
  - iv. 5pm Draw: cash prize of \$500, plus winner's choice of confectionery jar
  - v. 6pm Draw: cash prize of 1,000, plus winner's choice of confectionery jar

## **5. PRIZE DRAWS**

- a. A total of thirty (30) prize draws will be conducted, one (1) approximately every 60 minutes on Saturday 5<sup>th</sup> March 2022, Saturday 12<sup>th</sup> March 2022, Saturday 19<sup>th</sup> March 2022, Saturday 26<sup>th</sup> March 2022, Saturday 2<sup>nd</sup> April 2022 and Saturday 9<sup>th</sup> April 2022 (Draws at approximately 2pm, 3pm, 4pm, 5pm and 6pm on each of these days).
- b. Winners have a total of two (2) minutes to claim a prize from the time of being announced over the Club's public address system.
- c. It is the responsibility of eligible contestants to position themselves within Club areas where they can hear the public address announcements.
- d. If a selected winner does not present themselves to the compere within the two (2) minutes of being announced, that selected winner forfeits their claim to the prize and the compere, on behalf of the Promoter, will conduct a redraw and select another winner. This process will continue until a winner presents themselves to the compere within the two (2) minute timeframe.
- e. The winners will each receive a \$500 or \$1,000 cash prize, in accordance with the schedule outlined above as well as their choice of one (1) of the selection of confectionery jars on display.
- f. All winners must be present at the time of the draw to claim all prizes.
- g. A member can win a maximum of two (2) prizes each draw day. If a member gets drawn out for a third (3<sup>rd</sup>) time on one draw day, this will constitute a redraw.

## **6. LIABILITY TERMS**

- a. In the case of the intervention of any outside act, that hinders the Promoter's ability to proceed with the promotion on the dates and in the manner described in these terms and conditions, including but not limited to vandalism, power failures, natural disasters, the Promoter may in its absolute discretion take any action that may be available, and to cancel, terminate, modify or suspend the promotion.
